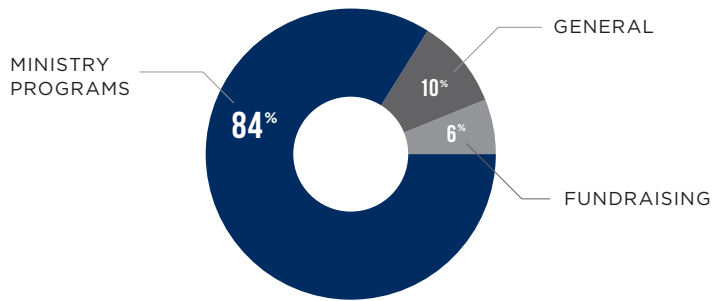


STEWARDSHIP OF YOUR INVESTMENT

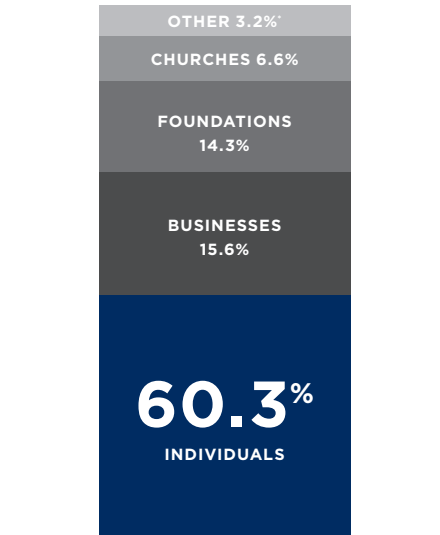

CONTRIBUTION REVENUE

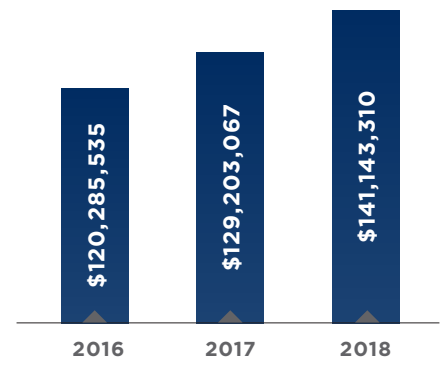

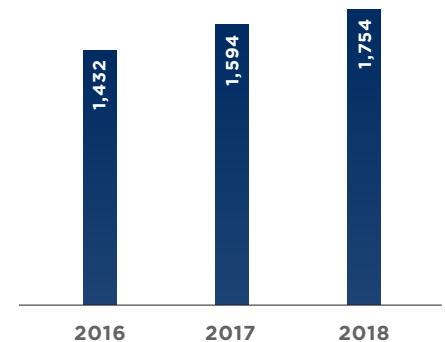
